Requirements for the design of the text of reports submitted for printing

Submitted texts should be edited and meet the following requirements:

- A4 pages, margins: left - 3cm, right - 1.5cm, top and bottom - 2cm;
- font: type - Times New Roman, Times New Roman Tj, size (kegle) - 14;
- first line - title of the report in uppercase letters - center alignment;
- second line - author's surname and initials - center alignment;
- third line - full name of the institution of the place of work (study) - center alignment;
- the main text typed in MS Word text editor: line spacing - 1.0, width alignment, automatic word transfer function is not allowed;
- the text volume should not exceed 6 pages (Formulas should be typed only in the "Formulas" editor);
- references to literature in the text are obligatory and should be formatted as follows: [3, p.25; 5, p.33-36], where the first digit is the number of the source in the literature list, the second digit is the page;
- the list of references is located at the end of the paper after the word "Literature" and is arranged in alphabetical order;

Special scientific-theoretical and practical suggestions and recommendations should be given at the end of the article.

The text of the article is presented in 1 copy on paper and in electronic form in RTF format.

The article should reflect theoretical issues related to the topic and their practical solutions.

INDEXING OF CONFERENCE PROCEEDINGS

Each article accepted for the conference is placed in the international databases Index Copernicus Poland, Zenodo and Open Aire Europe, Cyberleninka Russia, as well as indexed in the international search engine Google Scholar. An individual DOI number is given for each article.

Conference participants will receive an electronic copy of the certificate, an index certificate and a pdf-version of the indexed article. The conference proceedings will be published electronically.
